Mount Calvary pledges \$200,000 to Luther Park through "Mission Ready" Capital Campaign

ission Ready is the theme of Mount Calvary Lutheran Church in Excelsior's Capital Campaign. In addition to refreshing their facility to the tune of \$1 million dollars or more, in several areas

where needed, the congregation also intends to raise another \$500,000 to "Boldly grow our benevolence to support our historic mission partners."

Luther Park became one of those 'historic mission partners' back in

1958 as one of 14 charter member congregations that agreed on the importance of outdoor ministry and eventually made Luther Park Bible Camp a reality.

Mount Calvary members now agree that as original founders, it's time to take the camp and its setting into the future by contributing to the building of a Retreat Center. "People need a place to get away" explained one member. As their campaign infor-

mation notes, thier goal is to: "Provide a leadership level gift, as a 1958 charter church, to help Luther Park Bible Camp build an Adult and Family Retreat Center.

"Other 'historic mission partners' to benefit from the Mission Ready Campaign include: Renovating and expanding the

medical clinic founded in 1995 in Desma, Nigeria, strengthening their partnership with the Jimeta congregation; and providing \$100,000 to fight hunger here and around the world through Kids Against Hunger,

ICA and ELCA World Hunger."

The Mount Calvary campaign is basically about Mission. Onethird of the funds raised will go to outreach in the community and around the world.

We were joined by wonderful campers and led by a very talented group of college-age staff members, including four international staff. Dan Bennett, 2011 summer staffer, has become our year-round retreat host! He and Kara Hartman, 2010 summer staffer, will serve as our 2012 summer program directors.

Our board members and corporate congregations were active as volunteers and fundraisers. Our 2011 fundraisers (Bike-a-thons, Quilt Auction, Ole & Lena dinner, & Glad Tidings dinner) brought in over \$51,000. Thrivent Choice Dollars brought in \$10,000. Congregations provided over \$34,000 (individual church support ranged from \$100-\$10,000).

We are so grateful for prayers and generous donors. Individuals gave over \$90,000. One generous donor provided a year-end gift of \$50,000 designating \$25,000 for the annual fund and \$25,000 for the new Retreat Center. One of our congregations has committed \$200,000 of its spring campaign for our new Retreat Center.

Thanks to volunteers, Birch cabin was renovated, buildings were painted, The Point has power, and the Canteen is winterized. Volunteers also helped us clean up after a summer storm and keep generators going for five days.

About the Board of Directors and Executive Committee

The 2011, the board of directors and Executive Committee consisted of: David P. Shirley (President), Janet Nelson (Vice President), Deana Miller (Secretary) and Randy Johnson (Treasurer). We met quarterly throughout the year and provided the policy/administrative management of the Luther Park Corporation.

Throughout 2011, the Executive Committee convened jointly with the Finance Committee prior to the quarterly board meetings to review Luther Park's financial condition, along with establishing agendas for the quarterly board of director's meetings. In its role as a Personnel Committee, the Executive Committee also monitored staffing levels and changes.

We have been excited for the progress toward renovations of existing camp facilities and deeply appreciate the resources and "sweat equity" put forth in cabin renovations and other projects. We hope the positive results of the initial two cabin renovations will generate additional commitments to update the remaining six cabins in the next 12-24 months, along with other projects.

Gifts from individuals in 2011 were encouraging, and despite the last few years of cutting expenses to better keep spending in line with income, we are fielding increasing praise from those using Luther Park for summer camp, retreats and special events. The board has been managing the finances of the prior sale of land to keep the Fit for the Next 50 renovations going with matching funds.

Luther Park received another exciting development in our somewhat prolonged quest to realize a Family Retreat Center with a generous financial commitment (\$200,000) by Mount Calvary in Excelsior as part of a capital campaign fund. Although I will not realize the construction of a retreat facility during my expiring term as a Luther Park board member and current President, it is still my endless passion that we will achieve this goal in the next couple of years.

As retiring President of Luther Park, please share in my thanks and great appreciation for the dedicated board members, staff and countless volunteers that keep this tremendous Christian ministry moving forward.

There is no amount of praise that could mirror the amazing dedication of these servants of the Lord.



he Luther Park Corporation held its 2011Annual Meeting Sunday, March 17, 2012, at Northeast Community Lutheran Church.

Board President David Shirley called the meeting to order and welcomed everyone. Pastor Craig Pedersen noted he was privileged to have everyone at NE Community. He gave a brief history of the formation of the church followed by the opening

Secretary Deana Miller presented the minutes of the 2010 annual meeting. They were approved as presented. Executive Director Joel Legred welcomed and thanked everyone for attending and presented a Luther Park video from Summer 2011.

FINANCIAL REPORT/PROPOSED ANNUAL BUDGET

The 2011 financial report was reviewed by Joel Legred in he absence of Treasurer Randy Johnson. Some items were highlighted. Joel suggested people call him if they have questions about the Independent Accountants Compilation Report or the Statements of

- Send the Registration and Health History Form with a \$200 deposit to Luther Park. The deposit is not refundable and non-transferable after May 1.
- Final payment is due at the camp office two weeks prior to arrival at camp.
- Upon receipt of registration materials, confirmation, directions to camp, and notice of balance due along with other important information will be e-mailed to you, unless you direct otherwise.
- Registration is on a first-come basis.

Luther Park Bible Camp Code of Conduct



- 3. Campers must be accompanied by a Luther Park staff person whenever outside of camp property.
- 4. We are pleased to offer an alcohol-free, smoke-free and substance abuse-free environment. Exceptions must be approved by the director.
- 5. Luther Park is a weapon-free environment. Campers may not bring any kind of weapon or explosive device, including firecrackers to camp. Use of any object as a weapon to hurt a person, animal or property will not be tolerated.
- 6. Luther Park reserves the right to store campers' personal items that may be inappropriate to their stay. Items will be returned for the trip home upon permission of the parent(s).
