



## Summer 2020 Waiver and Release Form: Camp at Home

I give my child(ren) permission to participate fully in Camp at Home with Luther Park Camping & Retreat Center. I acknowledge that Camp at Home is a mix of interactive Zoom sessions led by camp staff that have undergone a background check and training, pre-recorded online video content, and at-home, off-screen activities.

I understand and agree to the following:

- Camp staff refers to adults hired by Luther Park and have undergone training and a background check.
- I retain full supervisory responsibility for any and all activities that happen as part of Camp at Home.
- I will not expect camp staff to provide supervision for my child(ren).
- I, or another parent/guardian, will be close by when my child(ren) participate in Zoom sessions.
- That participation in these events is at my and my child(ren)'s own risk. While measures are being taken to manage any activity risk, there is still the risk that something unexpected may happen. If my child(ren) gets hurt while participating in Camp at Home activities or any activity recommended by Camp at Home, I will assume full responsibility.
- Appropriate participant behavior is expected with all Camp at Home activities.
- That the Zoom sessions are completely optional and are meant to be a space for my child(ren) and Camp staff to connect, engage and be safe. Camp Staff and my child(ren) will do their best to maintain a safe space for everyone and engage with each other in a safe way.
- That the Zoom sessions that my child(ren) chooses to participate in will be closed and will only allow registered participants and approved camp staff to participate.
- That it is my responsibility to teach my child(ren) about internet safety, online search safety, online communication, oversharing, and cyberbullying prior to the first Zoom session.
- That Camp staff have permission to turn off your child(ren)'s microphone or remove them from a Zoom session if they are acting inappropriate. This includes but is not limited to racist comments/slurs, teasing, fighting, threats, swearing, and any other behavior that is demeaning to another person.
- That Camp staff have permission to turn off your child(ren)'s camera or remove them from a Zoom session if they are displaying inappropriate clothing, hand signals, posters, comments, backgrounds, etc.
- That my child(ren) will be dressed appropriately while participating in Zoom sessions.
- That my child(ren) must be in an appropriate location with an appropriate background. It is preferred that my child(ren) are not in their bedroom, as this risks their safety and privacy.
- That no two-way communication (texting, messaging, chatting, etc) will be allowed between the Camp staff and my child(ren) unless this has been approved and pre-arranged by both me, as the parent/guardian and the Program Director.

- That the Zoom sessions will always be facilitated by at least two approved Camp staff with at least two children and one approved Camp staff in each breakout room. The overall facilitators may join the breakout room at any time.
- That the Zoom sessions will only be recorded by Camp staff to only be used as reference if a problem or concern arises. My child(ren) is/are not allowed to record the Zoom sessions on any device (including but not limited to a computer, a cell phone, a camera, etc.).
- That the Zoom sessions will only have a screenshot taken by the Camp staff. My child(ren) is/are not allowed to take screenshots or photos of the Zoom session. The Camp staff will alert the Zoom participants when a screenshot or photo is being taken. If a parent/guardian does not want their child(ren) or my child does not want to be in the screenshot, their camera may be turned off by either the Camp staff or the child(ren) to avoid being in the screenshot/photo. - That it is my responsibility to provide any equipment needed for virtual programs, such as a computer, tablet, internet access, headset, earphones, microphone, etc. I also understand that any damage to said equipment is the sole responsibility of the owner of the equipment. I will not hold Luther Park responsible for any damage that may happen during Camp at Home.

I agree to follow and will ensure that my child(ren) understand the following:

- Any private (one-to-one) electronic communication between staff and campers, including the use of social networking websites like Facebook, Instagram, Snapchat, instant messaging, texting, etc is prohibited.
- All communication between staff and campers must be transparent and public.
- Permitted communication channels: group sites where anyone who is a member can see the conversation.
- Preferred communication is between the parent and official Luther Park channels such as the Year-round Staff member's (Leah McDougall and Joel Legred's) phone or email address.

I release and promise to indemnify, defend, and hold harmless Luther Park Camping & Retreat Center, its staff, volunteers, and other participants for any injury or other loss arising directly or indirectly out of the described activity, whether such injury arises out of the negligence of the activity sponsor, the participant, or otherwise.
